# ACCA- CHARTERED CERTIFIED ACCOUNTANTS

ACCA stands for the Association of Certified Chartered Accountants, which is a global body that provides students with a 'Certified Chartered Accountant' certification. ACCA subjects include Business & Technology, Management Accounting, Financial Accounting, Corporate and Business Law, Taxation, Performance Management, Financial Reporting, Audit and Assurance, Financial Management, Strategic Business Leader, Strategic Business Reporting, Advanced, Financial Management, Advanced Performance Management, Advanced Taxation, Advanced Audit and Assurance.

ACCA subjects are divided into 3 levels which are Knowledge, Skills and Professional. Students have the opportunity to avail themselves of various ACCA exemptions based on their education. Students having a BCom or MCom degree will need to sit for 9 exams instead of 13 and students with CA will need to sit for 4 Exams instead of 13.

### **ACCA Admission**

ACCA students can take admission after class 10th. Although they will need to complete a Diploma course before starting on the main ACCA subjects which are 13 in number.

### **ACCA Eligibility**

The best part about ACCA is that it has almost no eligibility criteria. The basic eligibility criteria is mentioned below:

- Students with no formal education will be able to apply for ACCA Foundation. On passing the Diploma course for ACCA Foundation, students will be able to apply for ACCA qualification which is the main ACCA certification exam
- A student who has passed class 12 must have more than 65% in subjects like English, Mathematics and Accounts. Apart from these, students must have more than 50% in the other subjects.
