- **The candidates must have obtained minimum 50% aggregate marks in their graduation.**
- **The applicants will have to clear the cut- off set for the entrance exam. It must be noted that the cut-offs tend to vary each year depending upon several factors.**
- **The candidates are also required to perform well in the personal interview and group discussions which are meant to test their**



**knowledge of the subject. It usually takes place after the entrance examination.**

**The above-listed criteria are almost the same in the universities and colleges across the country that are providing this course to the students.**

However, there are universities and institutions that grant admissions solely based on the marks obtained by students at the undergraduate level.**

**Some of the top colleges that offer LLM in Taxation Law are National Law School of India University (NLSIU), Bangalore, National Law University, New Delhi, Chandigarh University, Nalsar University of Law (NALSAR), Hyderabad, National Law University, Jaipur, The West Bengal National University of Juridical Sciences (NUJS), Kolkata, etc. The average fee of the program ranges from INR 1,80,000- INR 6,00,000.**

- **To be eligible for the application in a program, a candidate must fulfill certain specific criteria set by various institutes.**
